**Job Title:** Community Occupational Therapist

<b>Job Purpose</b>	<ul style="list-style-type: none"> <li>Plan, deliver and evaluate Occupational Therapy (OT) interventions to facilitate the recovery of individuals to promote independence and enable them to lead independent and fulfilling lives. This role will cover the East and West Midlands, including as well as some surrounding areas including Yorkshire and the Humber (e.g. Doncaster, Hull, Scunthorpe, Grimsby) and Peterborough</li> </ul>
<b>Accountabilities</b>	<ul style="list-style-type: none"> <li>Assessment of individuals to identify occupational needs, case management and delivery of professional support, working as part of a Multidisciplinary Team (MDT).</li> </ul>
<b>Main Responsibilities</b>	<ul style="list-style-type: none"> <li>Deal appropriately and professionally with enquiries coming into the OT service, including managing referrals to and from outside agencies.</li> <li>Provide highly skilled OT assessment, treatment and evaluation for patients with complex conditions who are referred to the service, through group and one-to-one sessions online, in the community, and in the wider geographical area.</li> <li>Attend home and community visits/assessments as agreed with Line Manager which may often involve coming into contact with families / children.</li> <li>Educate and advise individuals, their families, and carers to facilitate self-management of their condition and optimise their recovery potential and quality of life.</li> <li>Participate in MDT working to facilitate an individual's functional goals and cooperate in joint working where required.</li> <li>Provide information, advice and support for individuals to enable them to access statutory service provision i.e. Disabled Facilities Grants.</li> <li>Act as a source of expertise on the management of complex disability and advise internal and external stakeholders as appropriate.</li> <li>Attend home visits and assessments as agreed with the wider Clinical Team.</li> <li>Attend community participation events and residential courses as required.</li> </ul>



	<ul style="list-style-type: none"> <li>• Ensure data and information is recorded and handled with sensitivity, maintaining confidentiality in line with GDPR and Caldicott principles.</li> <li>• Take responsibility for one's own professional development, maintaining an up to date CPD portfolio.</li> <li>• Maintain professional registrations and adhere to The Royal College of Occupational Therapists 'Professional standards for occupational therapy practice, conduct and ethics'.</li> <li>• Adhere to Help for Heroes' safeguarding and risk management policies and procedures.</li> <li>• Adhere to the Help for Heroes Service Delivery Framework for OT.</li> <li>• Participate in and record mandatory clinical supervision.</li> <li>• Other duties as identified.</li> </ul>
